**\*\* Wrestlers only have to make weight once. They may make multiple attempts. \*\***

Times: Split start times will be used. The 11-12 and 13-15 age groups will start no sooner than 4:00 pm on Saturday. All other age groups will start at 10:00 a.m. on Saturday. Scratch Meeting will take place at 9:00 a.m. for lower age groups and 3:30 for 11-12 and 13-15 age groups. All age groups will start with the consolation semi-finals at 10:00 a.m. on Sunday.

Rules: 1. High school rules will be used. Skin checks of all wrestlers at time of weigh-ins. On site Physician will have ultimate determination of any questionable skin condition. In any event, if wrestler has a questionable skin condition a NFHS MEDICAL RELEASE FORM must be filled out by Dr. in order to compete in this event. Skin conditions must be treated for 3 days prior to wrestling in this event.  
2. Wrestlers not making weight will forfeit and will not be allowed to move up.  
3. Bout system will be used. The Tournament will be double elimination.  
4. All matches will be one minute periods up to the semi-finals which will be 1 – 1 ½ - 1 ½  
5. All overtime matches will be sudden death.  
6. This is a closed event. All wrestlers must reside in West Virginia. Proof of Age and Residence will be required if challenged prior to the start of the Tournament. Wrestlers who have wrestled a high school match or who have been listed on a high school roster will not be allowed to participate.

Age: **Age group will be determined by wrestler's age as of January 1, 2019.**

Seeding: Seeding Meeting will take place on Sunday February 17<sup>th</sup>, 2019 at 10:00 a.m. The location of the meeting will be at the Comfort Suites (167 Elizabeth Pike, Mineral Wells, WV 26150). Head Coaches are encouraged to attend. Entries must have records of wins and losses for seeding. Top 8 wrestlers will be seeded.

Info: No coolers will be allowed in the building. All tobacco products will be prohibited. Concession stand and Coaches' Hospitality Room will be available. Admission is \$5.00 each day.

Awards: **TOP SIX PLACE FINISHERS IN EACH WEIGHT CLASS WILL RECEIVE AN AWARD. PARTICIPATION MEDAL WILL BE GIVEN TO ALL NON-PLACING WRESTLERS.**
