Important Information:

- Team registration only
- HS teams will play a minimum of 4 games / MS & teams will play a minimum of 3 games
- 30 minute games
- Tournament held November 5, 2016
- All games played in Louisville, KY at EP Sawyer State Park
- Cost is \$500 per HS team / \$400 per MS team
 - Fee includes:
 - 3 or 4 games minimum (based on MS or HS divisions)
 - 2 certified officials per game
 - 7 v 7 field (40 x 60 yards)
 - Medical staff on site for all games
 - Onsite food and apparel vendors
 - Onsite lacrosse vendor
 - Onsite free parking

Rules & Regulations

1. All players must be current US Lacrosse members. Head coaches are responsible to certify.
2. Teams must wear matching uniform jerseys with numbers (preferred).
3. Game format is 7 vs. 7. Each team will have 1 Goalie, 2 Defense, 2 Midfield and 2 Attack.
4. Each team should begin each game with a minimum of 12 players.
5. Each game will consist of two 15 minute halves (Running Time), with a 5 minute halftime.
6. Each team has a 1 minute time out in second half only. Game time runs during TO until 1 minute left in the game. No time outs in the last minute of the game.
7. In the event of the tie, a 'Braveheart' will be used to determine the winner.
8. Face-off will occur at the beginning of each half only. Clears will occur after goals on the whistle. Exception - a faceoff will occur in the last minute of the game if the score is tied.
9. Attack & Defensive players must be at GLE to start all face-offs.
10. Penalties will not be time serving, but will result in a fast break for the offended team.
11. Defense can stack in an "I" formation on fast breaks. Attack must be at GLE to start.
12. Personal fouls will result in the substitution of the offending player. No time served.
13. All players must wear full equipment. Includes mouth guards, shoulder pads and arm pads.
14. Only 2 long poles will be allowed on the field at all times.
15. All substitutions must occur on the fly.
16. The playing field will be modified for 7 vs. 7 format.
17. All other rules of the NFHS rules.
